Increase accessibility to required and optional meeting materials for all CoDA members. Many members can't afford computers. Phone/tablet apps are formatted to download documents as a part of the app thereby allowing the user immediate access.

This makes it easier to help start a meeting, utilize required documents and read introductory material especially when/where limited by lack of financial resources or internet access.
