I have some grant writing, funding seeking experience. I am also a disabled veteran (Air Force, 71-75) In my past I was also an accomplished tradesman (machinist).

 Quite a bit. In my 38 years in 12 step recovery I have held every service position in the group and intergroup level and I have participated in and facilitated many group consciences.

Keeping in mind the non-professional nature of CoDA (Tradition Eight), I would like for codependency to one day be considered as a primary cause of all addictions. My master's thesis was on researching the efficacy of providing codependency treatment to chronic relapsing alcoholics and drug addicts, the premise being that the addictions were being used by many codependents to mitigate the symptoms of their codependency. Codependents Anonymous is, in my humble opinion, the most effective (and cost efficient) method of treatment for codependency.
